## PRIVACY STATEMENT

- In the course of using this website or availing the products and services via the online application forms and questionnaires, **The Bharuch District Central Co-Operative Bank Ltd.** may become privy to the personal information of its Customers, including information that is of a confidential nature.
- **The Bharuch District Central Co-Operative Bank Ltd.** is strongly committed to protecting the privacy of its Customers and has taken all reasonable measures to protect the confidentiality of the Customer information and its transmission through the world wide web and it shall not be held liable in any manner for disclosure of the confidential information in accordance with this Privacy Commitment or in terms of the agreements, if any, with the Customers or by reasons beyond its control.
- **The Bharuch District Central Co-Operative Bank Ltd.** endeavours to safeguard and ensure the security of the information provided by the Customer. **The Bharuch District Central Co-Operative Bank Ltd.** uses 128-bit encryption, for the transmission of the information, which is currently the permitted maximum level of encryption in India. The Customer would be required to cooperate with **The Bharuch District Central Co-Operative Bank Ltd.** in order to ensure the security of the information, and it is recommended that the Customers use 128-Bit encryption and must necessarily choose their passwords carefully such that no unauthorized access is made by a third party. To make the password complex and difficult for other to guess, the Customers should use a combination of alphabets, numbers and special characters like !, @, #, \$ etc. The Customers should not disclose their password(s) to anyone or keep any written or other record of the password(s) such that a third party could access it.
- **The Bharuch District Central Co-Operative Bank Ltd.** undertakes not to disclose the information provided by the Customers to any person, unless such action is necessary to: –
  - (A) Conform to legal requirements or comply with legal process;
  - (B) Protect and defend **The Bharuch District Central Co-Operative Bank Ltd.** rights, interests or property;
  - (C) Enforce the terms and conditions of the products or services; or compulsion of law under provision of RBI, Nabard, B.R.Act, PMLA Act, I.T. Act, \_\_\_\_\_ Notification of Central / State Govt., Finance Department.
  - (D) Act to protect the interests of **The Bharuch District Central Co-Operative Bank Ltd.**, or its members, or of other persons.
  - (E) The Customer authorizes **The Bharuch District Central Co-Operative Bank Ltd.** to exchange, share, part with all information related to the details and transaction history of the Customers to banks/financial institutions /credit bureaus/agencies/participation in any telecommunication or electronic clearing network as may be required by law, customary practice, credit reporting, statistical analysis and credit scoring, verification or risk management and shall not held **The Bharuch District Central Co-Operative Bank Ltd.** liable for use or disclosure of this information.
